1 Corinthians 15:1-8 (New Living Translation)

The Resurrection of Christ

15 Let me now remind you, dear brothers and sisters,^[a] of the **Good News** I preached to you before. You welcomed it then, and you still stand firm in it.² It is this **Good News** that saves you if you continue to believe the message I told you—unless, of course, you believed something that was never true in the first place.^[b]

³ I passed on to you what was most important and what had also been passed on to me. Christ died for our sins, just as the Scriptures said. ⁴ He was buried, and he was raised from the dead on the third day, just as the Scriptures said. ⁵ He was seen by Peter^[c] and then by the Twelve. ⁶ After that, he was seen by more than 500 of his followers^[d] at one time, most of whom are still alive, though some have died. ⁷ Then he was seen by James and later by all the apostles. ⁸ Last of all, as though I had been born at the wrong time, I also saw him.

1. (**Past few weeks**, at Omaxe) As I'm writing the complaint email, I see the upper half of Glory in the air above as he says pointing to Death Conqueror to the left: ***Tu usko kyu marwana chahti hai..? Tu usko kyu marwana chahti hai..?***
2. (**Past few days**) Glory in a boxy light blue shirt untucked over beige trousers stands behind me and brushes my teeth as we both stand in front of the mirror and the washbasin in the washroom. He has one of his arms around me as he brushes my teeth with another hand.
3. (**Past two days**) Glory in a boxy light blue shirt untucked over beige trousers says: ***Mujhe isko brush karwana padega.. Mujhe isko brush karwana padega..***
4. (**Past two days**) Glory slaps Death Conqueror on his cheeks one after the other as the hsort fellow walks backwards and he moves forward saying how dare him do such a thing!
5. (**Night**, July 18th) The upper half until slightly below the shoulders of a naked Glory in a dark background as looking to the left at Death Conqueror, he says in a sobbing pleading tone: ***Bhai isko mat rula.. Bhai isko mat rula..*** asking him to stop sending and moving his drones around and inside my body.
6. (**Yesterday afternoon**) As the drones abruptly hit the insides of my groin near the cervix, and I jerk and shout at the drones to get away as they're traumatizing me (on top of me already experiencing menstrual uneasiness and pain), I see the duo say: ***He's causing her pain. He's causing her pain.***

7. (Yesterday afternoon) The upper half of Akhila in the air with her hair falling at the back as she says looking down at me in a sobbing tone: ***Kartika, it all happened to you because of me. It all happened to you because of me.*** It doesn't make any sense to me for in what way did she influence the abusive and wicked decisions Death Conqueror made in his life? She only served as an encounter in his life that led to them getting married but how is she responsible for his wickedness? Moreover, she came into his life in 2022 and he has been this wicked way for a long time and the camera situation has been continuing since 2019 when I first got one hint about the same which later got confirmed in 2020 when I was at home at Omaxe. She didn't ask him to send cameras in my vicinity or make the prostitute website or send flying monkeys to mentally, emotionally and psychologically disturb me. It was rather him who told her to say emotionally abusive things to me while she was staying with me as my roommate in A-16, Vijay Nagar, Single Storey.

She didn't ask him to send Deepak at my workplace to further inflict direct emotional abuse from a close range. And if he was to blame his marriage on her and therefore (falsely) try to justify his act of abusing me by continuing the camera situation, then that would be a lie because the marriage and his bond with her wasn't forced but deliberate, and from what he indirectly communicated to me through several people, when he met her he had found the girl who was at his financial level - his right match. Additionally, he was insulting everything about me all the time, pointing out this or that flaw in my looks or portraying my looks and financial condition as being much worse than what they are. The short fellow shouldn't lie and try to deceive others by not taking responsibility or accountability for the wickedness that he intentionally inflicted on others. All the emotional abuse/cruelty was already there since 2019 which was disturbing me as the social environment around me was no longer *natural* but always affected and framed! As the vision of her saying the words to me repeats, I speak out in response to it that it all happened because of the short fellow because he chose to send cameras into our (my and my family's) private space and use flying monkeys to emotionally abuse us whenever we go out. She didn't ask him to send cameras and publicly strip my family members or even my stepmom inside whose groin he was sending cameras while still being with Akhila - as what was communicated to me when I was staying in A10 - few buildings left to A16. When I went downstairs to pick up my food order, the cook Ganga of A10 who lying on the bed along the wall in the hall said to me indirectly that my mom was being raped. This shows that he is a mentally demented person who has an abnormal drive to control, domineer and sexually abuse women to the point of raping and even killing them if the situation leads to it.

Keeping all these things in mind, it is quite clear that the short fellow Death Conqueror, though being with his right match - the rich and slim girl - continued to abuse me and my mom whom he should've rather respected as an elder. This shows his wicked nature and disregard of women as living beings with a real persona who experience things and get hurt.

8. (Yesterday night) Prof TRS suggests other professors of my department to go to Death Conqueror's house to ask him to stop the camera situation in my life and keep to his own life and stop disturbing me and my family as it has begun to have severe physical and emotional detrimental effect on me. Prof Debajyoti Chaudhary in an off-white tunic standing on MSB's second floor and Prof Senthil Kumar in a red t-shirt on the ground floor near the MSB's entrance also get flashed to me. The follow-up vision shows a crowd of people from the department standing inside Death Conqueror's

house as they all tell him to stop abusing me and our family. Prof TRS stands on the left, while Prof Debajyoti Choudhary stands on the right side of the semicircle. He acts innocent and speaks lies, that he doesn't know what they are talking about, and that he is innocent - what my dad said to me he was apparently saying on phone on a conference call (it could be a lie that my dad told me). They reply firmly that they KNOW the truth and that he should stop doing what he is doing as they all stand confronting him inside his house.

9. (Yesterday night) As I lay crying in bed during the day as the drones keep brushing against my breasts and other body parts, I see the upper half of the dusky man in black as he says to others: ***We've to kill her. She can get us killed. We've to kill her. She can get us killed.***
10. (Yesterday night) Glory in a boxy light blue shirt untucked over beige trousers sits on my left on the floor against my trolley with slightly vertically folded knees with a protruding erect light brown penis as he says crying that when I cry, he cries too. He says it a few times.
11. My dad in a polo t-shirt gets hit on his head from behind as he holds his head with both hands in dazzlement. The follow-up vision shows my youngest brother Divyanshu standing behind him with a cricket bat held in his hand as he says: ***Jyada bada banega..!?***
